

Form M1PR, Homestead Credit Refund (for Homeowners) and Renter Property Tax Refund 2014

Leave unused boxes blank. DO NOT USE STAPLES.

Personal information section including fields for names, social security numbers, addresses, and birth dates.

Status section with ovals for Renter, Homeowner, Nursing Home or Adult Foster Care Resident, and Mobile Home Owner.

Fund section for State Elections Campaign Fund and Political party and code number.

Household Income section with lines 1 through 8 for calculating total household income.

Renters section with lines 9 and 10 for renter property tax refund.

Homeowners section with lines 11 through 14 for homestead credit refund.

All Applicants section with lines 15 through 17 for final refund calculation.

You must sign the second page. The direct deposit option is also on the second page.

Schedule 1—Special refund. To qualify, you must have owned and lived in this homestead both on January 2, 2014, and on January 2, 2015. If you qualify, see the instructions.
