



The Petroleum Tax Unit is responsible for collecting motor fuel tax on gasoline, special fuel, aviation special fuel and aviation gasoline in Minnesota. We collect inspection and cleanup fees on petroleum products received in Minnesota. We also issue petroleum licenses to distributors, special fuel dealers and bulk purchasers, along with issuing certain gasoline and special fuel refunds.

We are making improvements to how we provide petroleum data and information. We will no longer be issuing the annual report. We will now provide comprehensive tax information in an Excel spreadsheet format on our website. We think you will like this new way of receiving petroleum data. The information will be current and available in a printer-friendly format.
