Qhov nyiaj thim no muaj rau cov neeg yuav tsev thiab cov neeg xauj tsev uas siv nws tus Social Security Number lossis Individual Taxpayer Identification Number (ITIN). Koj cov nyiaj khwv los yuav tsum tsis tshaj li qhov muaj teem tseg thiaj li muaj feem tau.

Nyiaj thim tshwjxeeb rau qhov se rau lub tsev (tus neeg yuav tsev)

Yog koj yog tus yuav lub tsev, koj yeej muaj feem rau qhov nyiaj thim tshwjxeeb no tias cov nqe nram qab no muaj tseeb:

- Lub tsev yog koj li thiab koj nyob hauv lub tsev thaum lub 1Hli tim 1 txhua txhua xyoo.
- Qhov se rau koj lub tsev nce tshaj li 12% (6% rau xyoo 2022)
- Qhov se rau lub tsev nce muaj li \$100

Tsis zoo li qhov nyiaj thim txhua xyoo, qhov nyiaj thim tshwjxeeb no tsis ceev koj cov nyiaj xyoo koj khwv tau los.
