MINNEAPOLIS - SAINT PAUL AREA -- Anoka, Carver, Chisago, Dakota, Hennepin, Isanti, Ramsey, Scott, Washington, and Wright. For the 2019 report there are less than four businesses reporting in the Minneapolis - Saint Paul Area and these businesses are distributed to other regions. The re-distribution is intended to be equitable and to create minimal distortions.

NORTHEAST MINNESOTA -- Carlton, Cook, Itasca, Kanabec, Koochiching, Lake, Pine, and St. Louis.
