Xa nyiaj ncaj qha rau hauv lub chaw ceev nyiaj (Direct Deposit)

- Qhia kom paub txog qhov xa nyiaj ncaj qha (Direct deposit): muab koj ib daim tshev es siv tsis tau los yog mus tej lej account ntawm tus checking/saving routing thiaj account nab npawb.

Nyiaj Khwv Tau (Income)

Cov Qhab Nes (Credits)

- Nqi them zov menyuam: them tag nrho yog npaum cas, tus neeg zov menyuam lub npe, lub chaw nyob, tus lej cim ua se tax ID los yog tus lej Social Security number
