Kuv puas muaj feem tau qhov Child Tax Credit?

Raws li ib txwm, koj yuav tsum muaj raws li cov nqe hauv qab no koj thiaj muaj feem tau qhov Child Tax Credit.

- Koj yuav tsum nyob rau hauv Minnesota kom tau ib xyoo lossis ib tog xyoo rau xyoo 2023 no (cov neeg ua tub nrog thiaj tsis raug nqi nov).
- Lwm tug yuav tsum tsis txhob lees koj rau hauv lawd cov se.
- Koj muaj ib lossis ob tug menyuam uas “muaj feem” raws li IRS qhia tseg.

Tau Pe Tsawg?

Qhov credit ntau tshaj plaws yog \$1,750 rau ib tug menyuam tsis muaj 18 xyoo, pestsawg tus los tau tsis txwv. Qhov credit ntawm yog koj cov nyiaj tshaj \$35,000 rau ib khub niamtxiv ces nws txawj tsawg zujzus lossis \$29,500 rau lwm cov neeg fia se (tax). Nws txo li ntawm 12% ntawm koj cov nyiaj khwv tau los lossis koj cov nyiaj tau los tagnrho tom qab rho se tag seb qhov twg yog qhov ntau zog.

Tau Pe Tsawg?

Yog koj cov nyiaj khwv los yog \$8,750 lossis tshaj, qhov credit siab tshaj yog los ntawm seb koj muaj pestawg tus menyuam muaj feem uas yog cov muaj 18 xyoo lossis loj dua.:

- \$350 rau qhov uas tsis muaj cov menyuam muajfeem
- \$1,275 rau ib tus menyuam muaj feem
- \$2,450 rau ob tug menyuam muaj feem
- \$2,850 rau peb tug menyuam muaj feem
