

Txhob cia qhov Child and Working Family Tax Credits dhau mus!



Txawm tias luag tsis kom koj ua Minnesota ntaub ntawv se, koj yeej tseem ua Minnesota se kom tau cov txiaj ntsig ntawm cov se. Qhov Child Tax Credit thiab Working Family Credit txo se rau cov neeg uas cov nyiaj khwv tau poob nqe tshaj li qhov teem tseg. Ob qho qhabnias thim tau nyiaj rov qab rau koj, txais tau tias koj txawm tsis muaj se them los koj tseem yuav tau nyiaj rov qab los.

Child Tax Credit thiab Working Family Credit yog dabtsi?

Qhov credits ua ke tshiab no muaj rau pejxeem Minnesota uas ua tau raws lis cov kev xav tau ntawm cov nyiaj tau los. Cov credits no yog Working Family Credit, cov Child Tax Credit, thiab Credit for Qualifying Older Children.

Working Family Credit yog muaj rau cov pejxeem Minnesota uas ua haujlwm rau xyoo ntawd. Qhov credit yog sib npaug li 4% ntawm koj cov nyiaj tau los txog lis \$350.

Child Tax Credit yog muaj rau cov pejxeem Minnesota uas muaj cov menyuam tsis tau muaj nub nyoog 18 xyoo. Los ntawm kev ua cov ntaub ntawv Minnesota se, koj muaj feej tau li \$1,750 rau ib tug menyuam tsis hais muaj pestsawg tus menyuam li:

- \$1,750 rau ib tug menyuam
- \$3,500 rau koj ob tug menyuam
- \$5,250 rau koj peb tug menyuam
- \$1,750 ntxiv rau ib tug menyuam

Qhov credit tshiab rau Qualifying Children tsim nyog rau cov pejxeem Minnesota rau cov muaj menyuam loj. Qhov credit tau tso cai rau cov menyuam loj hlob:

- \$925 rau ib tug menyuam hlob uas tsim nyog
- \$2,100 rau ob tug menyuam hlob uas tsim nyog
- \$2,500 rau peb tug menyuam hlob uas tsim nyog

Piv txwv

Cia hais tias koj cov nyiaj khwv tau los yog \$25,000 thiab koj muaj ib tus menyuam tsim nyog hauv tsev kawm ntawv middle school thiab ib tus menyuam loj hlob hauv tsev kawm qib siab. Koj yuav tsim nyog tau txais qhov nyiaj

siab tshaj yog \$350 rau Working Family Credit, \$1750 credit rau ib tus menyuam tsim nyog, thiab \$925 rau ib tus menyuam loj hlob. Thaum ua daim ntawv Schedule M1CWFC, Minnesota Child and Working Family Credits, koj qhov credits tag nrho yuav yog \$3,025.

Kuv yuav txiav txim tau li cas yog kuv muaj ib tug menyuam tsim nyog los yog ib tug menyuam loj hlob?

Thov tshuaj xyuas cov lus qhia hauv Schedule M1DQC, *Dependents and Qualifying Children* los txiav txim seb koj puas muaj cov menyuam tsim nyog lossis tus menyuam loj hlob.

Puas muaj kev txwv rau cov nyiaj khwv tau los?

Tag nrho peb qhov credits pib tawm thaum koj cov nyiaj tau los ntau dua \$35,000 yog tias koj daim ntawv ua se yog Married Filing Jointly, lossis tshaj \$29,500 rau lwm cov neeg ua se. Cov nyiaj credits no cuam tshuam los ntawm koj cov nyiaj tau los. Los txiav txim seb koj puas tsim nyog tau cov credits no, ua daim ntawv Schedule M1CWFC, *Minnesota Child and Working Family Credits*.

Kuv yuav ua li cas thiab txais tau cov qhabnias no?

Qhov se rau xyoo 2022 thiab ntov zog, lees txais qhov Working Family Credit los ntawm kev siv daim Schedule M1WFC, Working Family Credit. Qhov Child Tax Credit tsis tau muaj, yuav tau tos kom txog lwm xyoo ua se rau xyoo 2023 tso. Qhov se rau xyoo 2023 thiab pes suab, lees txais yuav ob qho Child and Working Family Tax Credits los ntawm kev siv Schedule M1CWFC, Minnesota Child and Working Family Credits.
