Cov Nyiaj Thim Tau Ntau Tshaj Plaws yog:

- \$925 rau ib tug menyuum hlob uas tsim nyog
- \$2,100 rau ob tug menyuum hlob uas tsim nyog
- \$2,500 rau peb tug menyuum hlob uas tsim nyog
