Thov cov nyiaj se rov qab los (refund) pab koj them cov nqi xauj tsev!



Koj tuaj yeem tsim nyog tau txais cov nyiaj se rov qab yog koj tsev neeg cov nyiaj ua haujlwm tsawg dua \$73,270.

Kuv yuav tsum muaj dab tsi los thov cov nyiaj se rov qab (refund)?

- Daim Form M1PR, Diam ntawv Homestead Credit Refund (rau cov neeg yuav tsev) thiab Daim ntawv se xauj tsev (Renter's Property tax Refund).
- Koj daim ntawv them nqi xauj tsev (CRP).
 - Koj tus tswv xauj tsev yuav tsum muab daim CRP rau koj ua ntej January 31, 2024.
 - Koj yuav tau txais ib daim CPR rau ib qhov chaw koj xauj rau xyoo ntawd.
Ceeb toom: Koj cov nyiaj se tau rov qab tej zaum yuav ncu lossis tsis tau yog koj tsis muab daim CRP nrog.

Kuv yuav file lis cas kom tau cov nyiaj se rov qab?

- **Xa hauv computer (electronically):** Siv ib qhov software ua se los npaj los yog xa daim ntawv Form M1PR. Tej zaum muaj nqi yog koj siv cov software ua se.
- **Xa Ntawv:** Mus rau www.revenue.state.mn.us download thiab ua kom tiav daim Form M1PR. Xa diam ntawv koj ua tiav thiab koj cov ntawv CRP.

Thaum twg kuv yuav tsum tau file?

Rau koj daim ntawv ua se xauj tsev rau 2023 ua tsum tau file ua ntej August 15, 2025.

Cov lug nug rau cov neeg xauj tsev txog cov nyiaj se rov qab

Yuav ua li cas yog tias kuv tsis tau txais daim ntawv them nqi xauj tsev (CRP) los ntawm kuv tus tswv xauj tsev?

Hu rau koj tus tswv tsev lossis tus thawj saib xyuas khoom kom muab koj daim ntawv them nqi xauj tsev (CRP) rau koj.

Yuav ua li cas yog tias kuv daim CRP muaj cov ntaub ntawv tsis raug lossis tsis yog.

Hu rau koj tus tswv xauj tsev lossis koj tus thawj saib xyuas khoom kom ua cov ntaub ntawv kom yog.

Yuav ua li cas yog kuv tus tswv xauj tsev tsis kam muab lossis kho daim CRP lossis tsis teb kuv?

Yog koj tsis muaj ib daim CRP lossis daim CRP kho tau ua ntej March 1, hu rau peb ntawm 651-296-3781 lossis 1-800-652-9094.

Peb tauj yeem xa koj ib daim ntawv xauj tsev them rau koj los siv ua daim ntawm them nqi xauj tsev (CRP).

Yuav ua li cas yog tias kuv tsis muaj nyiaj lossis kuv cov nyiaj tau los tsawg dua kuv cov nqi xauj tsev?

Thaum ua daim Form M1PR, txuas ib daim ntawv qhia txog qhov koj tau txais cov nyiaj los them koj cov nqi tsev li cas. Qhov no kuj tseem siv tau yog kab 1 tsis sib npaug nrog koj cov nyiaj tau los ntawm tsoomfww (federal adjusted gross income) los ntawm kab 1 ntawm daim ntawv M1, Individual Income Tax (cov nyiaj tau los ntawm koj tus kheej).
