EXPLANATION OF THE BILL

In 2023 the one-time public safety aid provided \$300 million to some counties, cities, towns, and tribes that was to be used for public safety purposes.

The proposal would require jurisdictions that received aid to report to the commissioner of public safety the amount of aid received and how it was used or is planned to be used by January 15, 2025. The commissioner of public safety would compile the information and submit a report to the legislature by February 15, 2025.
