




# **Khawv Cov Receipts Rau Koj Tus Me Nyuam Cov Nqis Kawm Ntawv**


## **Cov nqis khoom ua pom zoo:**

- Khoom siv kawm ntawv (xaum, ntawv, calculators)
- Computer hardware thiab software ua siv rau kev kawm ntawv
- Kev ntiav cob qhia ntawv K-12 los ntawm ib tug xibfwb
- Xauj los sis yuav cov khoom paj nruag ua siv thaum kawm ntawv



## **Cov nqis khoom ua tsis pom zoo:**

- Khoom siv ua tsis yog siv rau kev kawm (hnab ev ntawv, ntaub so ntswg, cov khoom npaj cais khoom siv kawm)
- Khaub ncaws, suav nrog tsoos tsho kawm (tsuas yog tsoos tsho gym ua yuav tsum muaj)
- Su hauv tsev kawm ntawv
- tsev neeg mus ncig xyuas museum los sis zoo



## **Kuv puas tsim nyog tau kev pab?**

Kom paub seb koj puas tsim nyog tau qhov credit los sis subtracton, ob yam hauv qab no koj yuav tsum muab:

- Koj tau yuav cov khoom pab kawm ntawv los sis cov khoom siv kawm ntawv los pab rau koj tus menuam txoj kev kawm
- Koj tus menuam tab tom kawm Kindergarten mus txog qib 12 hauv ib lub tsev kawm ntawv rau pej xeem, tsev kawm ntawv private los sis kawm ntawv hauv tsev

## **Kev txwv ntawm qhov nyiaj khwv tau rau Qhov Kev Pab Cuam**

**K-12 Kev Kawm Credit:** Koj qhov nyiaj khwv tau tag nrho thiab tau kho yuav tsum qis dua li pom hauv qab no. Yog tias koj yeej tsim nyog tau qhov credit no, koj yuav tsum tau ua daim ntawv se hauv Minnesota thiab thov tau qhov nyiaj no.

Cov menuam kawm K-12:	Qhov nyiaj khwv tau thiab tau kho yuav tsum muaj tsawg dua:
1los sis 2	\$79,760
3	\$82,760
Ntau dua 3	\$85,760 thiab \$3,000 rau txhua tus me nyuam ntxiv
