

Dib-u-Celinta Canshuurta Hantida Minnesota: Hel Gargaar Canshuurta Hantidaada!

Dib-u-celintani waxay diyaar u tahay mulkiilayaasha guryaha oo leh mid ka mid ah Lambarka Diiwaangelinta Bulshada (Social Security Number) ama Lambarka Aqoonsiga Canshuurta Shakhsiyaadka (ITIN). Waa inaad buuxisaa xadad dakhli oo gaar ah si aad ugu qalanto.

Dib-u-celinta Canshuurta Hantida Gaarka ah

Mulkiilayaasha guryaha badanaa waxay u qalmaan dib-u-celinta gaarka ah haddii dhammaan shuruudahan hoose ay run yihiin:

- Waxaad lahayd oo aad ku nooleyd gurigaaga 2 Janaayo ee sanad kasta
- Canshuurta hantida gurigaaga waxay kordhay in ka badan 12%
- Kordhinta canshuurta hantidu waxay ahayd ugu yaraan \$100
