- Lub Minnesota Department of Revenue
- Lwm lub koom haum hauv tsoom fwv (suav nrog IRS los sis cov koom haum hauv xeev Wisconsin)
- Lwm lub koom haum uas xa nuj nqis mus rau Revenue
- Cov claims ntawm Revenue Recapture uas xa mus rau Revenue
