

## Minnesota Property Tax Refund: Txais kev pab them se vaj tsev!

Yog koj yog ib tug tswv tsev nyob hauv Minnesota, tej zaum koj yuav tsim nyog tau txais qhov Homestead Credit Refund los ntwam lub xeev. Qhov nyiaj them rov qab no yog los pab txo qhov se vaj tsev raws li koj qhov nyiaj khwv tau thiab qhov se vaj tsev.

Minnesota muaj ob hom kev pab cuam rau qhov them se vaj tsev rov qab rau cov tswv tsev:

### Regular property tax refund

Qhov nyiaj them rov qab no yog muaj rau cov tswv tsev uas muaj tus Social Security Number los sis tus Individual Taxpayer Identification Number (ITIN). Kom tsim nyog tau txais qhov no koj yuav tsum ntsib qee yam kev txwv ntwam qhov nyiaj khwv tau los.

### Special property tax refund

Cov tswv tsev tuaj yeem tsim nyog tau qhov special refund no yog tias cov hauv qab no muaj tseeb:

- Koj tau yuav thiab tau nyob hauv koj lub tsev txij li Hnub Tim 2 Lub Ib Hli txhua xyoo.
- Koj qhov se vaj tsev nce ntau dua 12%
- Qhov se vaj tsev tau nce yam tsawg kawg \$100

Tsis zoo li qhov regular refund, tsis muaj kev txwv ntwam qhov nyiaj khwv tau kom txais tau qhov special refund no.

### Yuav thov li cas

Koj yuav tsum xa daim ntawv thov qhov Property Tax Refund ua ntej **Hnub Tim 15 Lub Yim Hli**. Koj tseem muaj txog li ib xyoo ntxiv tom qab hnub uas yuav tsum xa tuaj mus.
